

## A Message from the Grand Viscount General

Dear fellow members,

This will be my last formal communication to you in my capacity as Grand Viscount General. It has been a great pleasure serving as the founder and the chief executive officer of our new heritage society. My goal was to obtain 100 members by Dec. 31, 2013. We exceeded that number by far. As of Feb. 17, 2014, our total membership is 162. The vast majority of our members have served as leaders of other national heritage societies, and most of you have served as national officers of other groups. This vast experience in other organizations will greatly assist our organization.

At our second annual meeting in Washington, DC in April I will pass the baton of leadership to a new national leader and an outstanding group of officers. I hope that each of you will lend your support to their requests for assistance.

Thus far we have chartered two state societies: Texas and California. Deputy Grand Viscount Lindsey Brock is now working on the formation of another group in the south-east. These state societies are where the rubber meets the road.

In late October, 2013, the OFNA Texas Society co-sponsored with the National OFNA a genealogy seminar and a three day historical exhibition and book fair in conjunction with the annual meeting of the Texas Heritage Societies. The Texas Heritage Societies is an amalgamation of 13 separate Texas groups of national lineage groups, including Colonial Wars, Sons of the Revolution, Colonial Dames of the 17th Century, Order of the Founders and Patriots of America, 1812, Washington's Army at Valley Forge, Military Order of the Stars and Bars, etc. As a result of this event, we had several new mem-

ber applications submitted.

The national society will again co-sponsor a genealogy seminar in conjunction with the Texas Heritage Societies annual meeting in October, 2014. This year the meeting will be in Dallas, and the feature speaker will be Lloyd DeWitt Bockstruck, our society's genealogical patron. Mike Radcliff will serve as chairman.

The California OFNA Society met for the second year with a similar, but smaller group of other lineage societies. Their meeting also generated some new member applications. Dep. Viscount General Steve Renouf will make a presentation in March to a group of heritage societies in San Jose, CA. Though annual meetings with other lineage groups we should be able to continue to generate new members.

It is my hope that you can organize many more state societies, and conduct events with other lineage groups. This way, they find out who we are and what we do. By putting on historical or genealogical seminars, book fairs, exhibitions, etc. we draw from the public at large, which will also serve to enhance our membership.

This year our annual meeting will be on Wednesday, April 9, 2014 at 3:30 p.m. At that meeting we will elect our new officers for the 2014-2015 year, consider some by-law amendments and other business. Starting between 5:00 p.m. - 6:00 p.m., we will conduct a no-host reception at the Willard Hotel. This reception was designed to attract member of the Heritage Society who will conduct their annual meeting at the Willard, starting with cocktails at 6:00. So, come to the meeting in your formal attire if you plan to attend the Heritage Society meeting. We need a strong showing from our members to assist us in some "industrial strength arm twisting" to secure some new members. I hope to see a big group in attendance.

After I turn over the leadership of the Order to my successor, it is my intention to remain active in the affairs of the Order as the Founder and as a lifetime member of the Board. It has been an honor and a pleasure to serve.

In this newsletter is the report of the nominating committee. Our Exchequer was forced to resign for health reasons. The nominating committee had not found a replacement by press time. There are a few other opportunities to serve. Please consider allowing your name to be placed into nomination.

Finally, a word about our newsletter, Larry Stevens has done a superb job as editor, but he needs appropriate articles from our members. He is looking for articles about the early settlement of French, Spanish, Dutch, Swedish and other ethnic groups in North America. If you have an interesting ancestor who was here before 1692, please compose an article and submit it to Larry.
